PRESIDENT'S LETTER



Thirty years young, WX remains a dynamic and thriving organization. We are financially stable. We have a high level of engagement. Membership is coveted. Our mission is supported more than ever before through

generous sponsors (and tireless fundraising efforts by our Gala committee). Our signature scholarship and mentoring program participants continually shine. The mission driven philanthropic initiatives are impactful. We should all take great pride in these accomplishments.

As WX members, we all have an obligation to leave our mark in some way and those that have come before us have done so beautifully. My sincere thanks to all of you who have served in leadership and on committees over the last 30 years, molding WX into the unique, purposeful and powerful organization it is today.

In preparing to write this letter, I went back to former President Suzanne St. Pierre's letter from Winter 2018, which spoke of a new WX initiative, "Building our Business Together." WOMAN OF THE YEAR: 2018 GALA RECAP

WX hosted its Annual 2018 Woman of the Year Gala honoring Cheryl Boyer on Thursday, November 15, 2018 at The Pierre Hotel. The soldout gala raised over \$608,000 -- a new record. Proceeds from the event support the WX Scholars and Mentoring programs, which aid talented young women in their pursuit of careers in the real estate industry. Steve Angel, Principal and Founder of Fulcrum Hospitality, introduced Cheryl saying, "Cheryl's dedication to giving back is embodied within her work at WX, ranging from mentorship of scholarship recipients and young women at the start of their professional careers, to holding posts as WX Past President of both the WX organization



itself as well as its Charitable Trust". Angel referred to Cheryl an "unstoppable force" and "is always giving of herself and there for [the team]." Recognized as an active industry leader, Cheryl is a Board Member and Immediate Past President of the Cornell Hotel Society, Membership Chair of the President's Council of Cornell Women and is a member of the Cornell University Council, Cornell Hotel School Dean's Advisory Board, Hospitality Asset Managers Association and Lodging Industry Investment Council. WX SCHOLARS PROGRAM: NOW ACCEPTING APPLICATIONS FOR 2019 SCHOLARS

The WX Scholars Program is pleased to announce that applications are now being accepted for the 2018-2019 academic year. The goal of the WX Scholars Program is to encourage and support bright and talented young women who are completing their undergraduate or graduate degree programs and who will be entering the real estate profession in the New York metropolitan area. The Scholars designation will be awarded based on criteria such as academic merit, demonstrated interest in a real estate career, and likelihood of working in the NY metropolitan area. Depending upon need, scholarships of up to \$10,000 may be awarded.

Since 2004, WX has made 269 awards totaling \$1.26 million to women at 15 schools. The WX Scholars are invited to participate in the WX Mentoring Program, a 2-year Program that matches Scholars with WX mentors from various segments of the real estate industry. The WX Mentoring program sponsors educational programming, professional development and networking opportunities for the Mentees. Additionally, the Scholars are invited to attend the annual Woman of the Year Gala, monthly breakfast meetings at The Harvard Club, and WX membership programming and activities on a select basis.

Participating schools include, but are not limited to Columbia University, New York University, Baruch College, New York Law School, City College of New York (CCNY), Pratt Institute, Rutgers University, University of Pennsylvania, Georgetown University, Lehigh University, Yale University, Harvard University, Cornell University, Massachusetts Institute of Technology, and Fordham University.

Application materials are now available on WX's website, and will be accepted until January 31, 2019. The Scholars Program Committee comprises WX members who are each dedicated to maintaining school contacts, reviewing applications, and interviewing applicants. 2018 SUMMER INTERNSHIP GRANTS

For the past few summers, the WX Scholars Program has awarded Summer Internship Grants to students who are developing careers in real estate and related fields, and who require financial assistance with housing or other living expenses while participating in their summer jobs or internships in New York City. This summer, five grants were awarded to students from four different schools, totaling \$25,000. The students worked in various real estate fields, including finance, development, landscape architecture, and affordable housing construction. Based on feedback we received from the participants, we know the WX Grants made a big difference in their internship experience.



The WX Summer Internship Grant helped give me some peace of mind while living in New York for the summer. It also provided me with a wonderful new network of like-minded women, both WX members and fellow grant recipients. As I pursue a career in New York real estate upon graduation in the spring, it will be invaluable to have this network of contacts, many of whom already live in the NYC area.

PHILANTHROPY COMMITTEE UPDATE:
