# NYC BUILT ENVIRONMENT LEADERSHIP SPEAKS ON STATE OF NEW YORK CITY CONDO MARKET AT THE HARVARD CLUB

When considering consumer behavior in the marketplace, John Tashjian, Founder and Principal of Centurion Real Estate Partners believes that sizable market returns depend on the resurgence of consumer and buyer confidence.

Alternatively, Jay Neveloff of Kramer Levin Naftalis & Frankel believes that new projects hitting the market will have to be priced to reflect current realities and that existing projects will be priced specific to that particular project and reflect the needs and requirements of those in the capital stack. Finally, Nancy Packes, President of Nancy Packes Inc. brought all aspects of the looming issues facing the condo market together through her dissection of the New York City condo market's development over the last few decades. Analyzing the pre- and post-Lehman periods, Packes showcased the rising price of condos across the Five Boroughs. While the future of the condo market may not be fully clear, all distinguished speakers offered their experiences and insights to help attendees understand the state of New York's condo market.
